

# **HIGHER EDUCATION EMERGENCY RELIEF FUND REPORT – CARES ACT EMERGENCY AID GRANTS TO STUDENTS and CORONAVIRUS RESPONSE & RELIEF SUPPLEMENTAL APPROPRIATIONS ACT**

In compliance with reporting requirements prescribed for above referenced grants, the following information is posted on Hair Professionals Academy's (G Skin & Beauty Institute-Oakbrook, Naperville, Chicago) website:

1. Hair Professionals Academy (G Skin & Beauty Institute) signed and returned to the Department of Education, the Certification and Agreement to receive funding under Section 18004(a)(1) of the Coronavirus Aid, Relief, and Economic Security Act ("CARES ACT"). No less than 50% of the funds received under this code section will be used to provide Emergency Financial Aid Grants to students. Hair Professionals Academy (G Skin & Beauty Institute) signed and returned the Certification and Agreement document in March 2021 for Emergency Student Grant Funds under the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA).
2. Hair Professionals Academy (G Skin & Beauty Institute-Oakbrook, Naperville, Chicago) received \$147,307 pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to students under HEERF and an additional \$251,192 under the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (HEERF II).
3. As of September 30, 2021, the total amount of Emergency Financial Aid Grants distributed to students under Section 18004(a)(1) was \$145,452.47 for students attending Hair Professionals Academy (G Skin & Beauty Institute-Oakbrook, Chicago, and Naperville campuses). Hair Professionals Academy (G Skin & Beauty Institute) has distributed \$194,696.53 to students attending Oakbrook, Naperville, and Chicago campuses from the funds received from HEERF II.

4. Approximately 209 students from Hair Professionals Academy (G Skin & Beauty Institute-Oakbrook, Naperville, and Chicago) students are eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and are thus eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act. Approximately 304 students from Hair Professionals Academy (G Skin & Beauty Institute-Oakbrook, Naperville, and Chicago) are eligible to receive Emergency Financial Aid Grants to students under the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRSSAA).
5. 209 students thus far have received an Emergency Financial Aid Grant under Section 18004(a)(1) of the CARES Act, and 227 students thus far have received Emergency Grants under HEERF II.
6. Hair Professionals Academy (G Skin & Beauty Institute) made awards to Title IV eligible students who were in attendance on or before March 3, 2020 and continued without disruption (without withdrawal or a leave of absence) online. The grants were awarded based on financial need as determined by the FAFSA with Pell grant eligible students receiving additional funds and the remainder to students who are using Federal Student Loan funding for their education. Based on this criteria, the amounts awarded ranged from \$551.44 to \$751.45 for students at Hair Professionals Academy (G Skin & Beauty Institute-Chicago and Oakbrook and Naperville Skin Institute students). The grants were mailed to the student's address currently on file with the school. For HEERF II, Title IV eligible students must have been in attendance between December 27, 2020 through March 18, 2021. The grants were awarded based on their financial need determined by the FAFSA with Pell Grant eligible students receiving the largest disbursement. Based on this criteria, the amounts awarded ranged from \$1050.00 to \$100.00. With the HEERF II awards, students had the option to elect to apply their funds to their student account. If the grant was not applied to their balance, the funds were mailed by check to the student's address currently on file.

7. Students were apprised of the school's plans to distribute the Emergency Financial Aid Grants for HEERF I and HEERF II via email and G Skin & Beauty Institute COVID information web-site. Students were not required to apply for these grants unless they had not filed a FAFSA, in which case an institutional application form whereby students attested to their Title IV funding eligibility was required.
